DECISION
ON
MEMBERSHIP CONTRIBUTION
BOARD OF NATIONAL DENTAL COUNCIL

- Having seen the Constitution of the Kingdom of Cambodia;
- Having seen the Royal Decree No. 0913/903 (Ref.), dated 24 September 2013, on the Appointment of the Royal Government of Cambodia;
- Having seen Royal code No. 02 (Ref.), dated 20 July 1994, promulgating the Law on the Organization and Functioning of the Council of Ministers;
- Having seen Royal code No. 1100/10 (Ref.), dated 03 November 2000, promulgating the Law on the Management of Private Professional Practice in Medical, Paramedical, and Medical Aide sector;
- Having seen the Royal Decree No. 0905/396 (Ref.), dated 02 September 2005, on the establishment of the Dental Council of Cambodia;
- Having seen Sub Decree No. 21 (Ref.), dated 13 March 2007, on the Training in Health Sector;
- Having seen Sub Decree No. 1356 (Ref.), dated 10 September 2014, on the Recognition of the component of Board of National Dental Council;
- Having seen the Decision No. 0019/15 (Ref.) dated 26 March 2015, on the Internal Regulations of the Dental Council of Cambodia
- According to the mandatory requirement.

DECIDES

Article 01:

Any dentists who wish to register in a list of Dental Council of Cambodia shall pay registration fee of 200.000 riels (Two hundred thousand riels) to the Board of Municipal and Provincial Dental Councils, where they practice medical profession, in compliance with article 36 of the Royal Decree on the Establishment of the Dental Council of Cambodia.

Article 02:

After becoming a member of the Dental Council, each member shall be obligated to make annual contribution to their respective Board of Municipal and Provincial Dental Councils, as follow:

- a. In Phnom Penh, it is required to pay an annual contribution of 300.000 riels (three hundred thousand riels) to the Dental Council.
- b. In Kandal, Battambang, Bantey Meanchey, Siem Reap, Kampong Cham, Tbong Khmum, Preah Sihanouk, Koh Kong, Takeo, Kampong Speu, Kampong Chhnang, Pursat, Prey Veng, Svay Rieng and Kampong Thom, it is required to pay an annual contribution of 240.000 riels (Two hundred and forty thousand riels) to the Dental Council.
- c. In Kratie, Steung Treng, Udom Meanchey, Kep, Preah Vihear, Mundol Kiri, Rattank Kiri and Pailen, it is required to pay an annual contribution of 120.000 riels (one hundred twenty thousand riels) to the Dental Council.

Article 03:

All foreign dentists who wish to practice their dental profession in the Kingdom of Cambodia, it is required that they must register in the list of the Dental Council of Cambodia. Foreign dentists shall pay for registration fee to the Board of Municipal and Provincial Dental Councils, where they practice profession, with 2.000.000 riels (Two million riels) and an annual contribution of 1.200.000 riels (One million two hundred thousand riels).

Article 04:

All foreign dentists, who wish to practice their dental profession in the Kingdom of Cambodia, are required to register in the list of the National Dental Council in order to obtain a permission letter and shall pay a contribution as specified below:

- a. 01 (one) to 30 (thirty) days, it is required to pay a contribution of 240.000 riels (Two hundred forty thousand riels)
- b. Over 01 (one) day, it is required to pay a contribution of 240.000 riels (Two hundred forty thousand riels) additionally
- c. Over 180 (One hundred eighty) days per year, it is required to register in the list of the Board of Municipal and Provincial Dental Councils, where they practice profession.

Article 05:

Foreign dentists, who have brought with benefits in the medical sector to the Kingdom of Cambodia, may not have to pay for registration fee/ annual contribution fee based on the decision of the office of the Board of National Dental Council.

Article 06:

The Board of National, Municipal and Provincial Dental Council are obligated to implement this decision.

Article 07:

Any other decision in contrary with this decision shall be abrogated.

Article 08:

This decision comes in force on the date of signing.
